- Through a contract, (part-time) Corporate Services employee Gary Novak was responsible for designing and building the chemical processing lab for Austin Peay State University. This lab will be used by the College to educate students and train employees for Hemlock Semiconductor Clarksville. Gary installed Delta College's chemical processing lab and also provides training in Delta College's Fast Start program. He will be attending the ground breaking ceremony in Clarksville on Thursday as a guest of HSC (one of 5 local staff invited to attend) and representative of Delta College Corporate Services.
- Delta College's service learning initiative has been awarded a \$20,500 'Pay It Forward' grant from the Michigan Campus Compact. This is the largest service learning grant Delta College has ever received.

The 'Pay It Forward' grants strengthen communities through student-led philanthropy grants that address critical economic needs in communities through student-led grant making and volunteerism. The purpose of this three state and national initiative is to develop a new generation of philanthropists through a course-based service-learning environment that engages college students in hands on philanthropy, grant-making and volunteer service.

Approved by the Board of Trustees at the October 2010 Regular Meeting.

Delta's team of faculty including Barb Handley-Miller, Lisa Lawrason, Jeff Dykhuizen, Denise Hill, Teresa Stitt, Michelle White, Gordie Stryker (community liaison) and Nancy Vader-McCormick will teach four individual courses this Fall and Winter infused with a philanthropy component; each course will award \$4,500 to up to three local non-profits as chosen by the class. Each student will perform a minimum of 15 service hours at an agency each semester.

Dr. Goodnow invited everyone to enter the Reflections photo contest. There are four categories for the public and one for employees, retirees and trustees. Learn more and submit your photos by September 27th at the College's website. The contest is in advance of our 50th anniversary to get the communities' prospective of Delta.

Dr. Goodnow distributed a copy of the College's new Delta Facts brochure, a DVD of her State of the College Address, and an article on the Innovation Incubator Program that was recently submitted to the League for publishing.

E. Wacksman said that she had the pleasure of participating in the official launch of the Bay Metro Green Line Route. The route takes students and community members from the Meijer Parking Lot (Wilder Rd.) to Delta College, SVSU, and back. Goodnow said that Linda Petee and Larry Ramseyer were instrumental in getting the route established.
