PUBLIC COMMENTS

Board Chair, R. Stafford, called for public comment.

Dennis Browning, Mayor of the City of Saginaw, thanked the Trustees for all of the work that they are putting into the decision for a new Saginaw Center. He said that the City of Saginaw supports Delta College. Specifically, he said that he would like to address the comments made by Trustee Emrich at the last Board Meeting regarding the inability to buy a toothbrush in Downtown Saginaw. Mayor Browning took a toothbrush from his pocket and told Dr. Emrich that he had purchased it in Downtown Saginaw from Medwin's Pharmacy. He again thanked the Board for the hard work that they have put into this process for selecting a zone.

TREASURER'S REPORT

D. Lutz said she has received the financial statements for the end of the month of March. Three more months remain in this fiscal year. The College remains in good cash position. She said that she is confident that the College will end the year in the black, but enrollment is down. This means that revenue is expected to be down approximately \$600,000. The College will also be over budget in instructional salaries for adjunct and supplemental pay. The College is under budget in vacancies because several positions have gone unfilled for a large portion of the fiscal year. We have received information on the first 7 months of the College's self-funded insurance claim history and expect some savings in this area. D. Lutz said that at this time she has no additional variances to report.

SAGINAW CENTER ZONE RECOMMENDATION (BA5048)

J. Goodnow said that before she makes the recommendation this evening, she would like to thank all who wrote letters in support of the Delta College Saginaw Center project.

It is the recommendation of the Administration that the Board of Trustees approve the City of Saginaw (Downtown Zone) for the location of a new Saginaw Center and authorize the Administration to move forward with the evaluation, selection, and recommendation of a site within the zone.

K. Lawrence-Webster made a motion to approve the recommendation with support from K. Houston-Philpot.

R. E. Selby made a substitute motion that the Delta College Board select the Buena Vista site at the North West Corner of M-46 and Outer Drive as the site for developing and

building a Saginaw Center. And that the College Administration begin formal negotiations related to such a project. Should, in the process of such negotiations, an actual and material fact or representation made by the Buena Vista DDA prove to be otherwise than stated in its presentations to the Delta Board, the Delta Administration shall refer the manner back to the Board which may vote to cease negotiations and withdraw its intent.

The substitute motion was seconded by R. Emrich.

Dr. Curry holds a Ph.D. in Educational Leadership from the University of Pennsylvania and has continued her education by earning a certificate in Urban Education from Hamline University and an Executive Leadership certificate from Notre Dame. Dr. Curry brings a wealth of knowledge and experience in the academic arena including over 25 years of teaching experience, serving 14 years as full-time faculty in Health Sciences. She currently works at Richard Stockton College in New Jersey as the Executive Director of the Stockton Center for Community Engagement.

David Redman has been reappointed as Chair of the Mathematics Division. His second term begins on May 1, 2014 and ends on April 30, 2017.
