Information Sharing

- Dr. Goodnow said a copy of her proposed goals for the 2016-17 Academic Year has been included in your folder this evening. She asked that Trustees review them and provide feedback and/or additional items to add.
- Last spring, I reported to you that I was serving on a study committee on the block transfer of associate degrees in Michigan. The committee was initiated by Michigan Legislators. The study committee recommended that Michigan take two steps to improve transfer.

The first is to "create a collaborative foundation for prioritization, dialogue, and planning," through the formation of a representative body that will act as a Steering Committee for all state-level transfer and articulation initiatives in Michigan.

The second is to "create a student portal to share transfer information."

Dr. Goodnow has been asked to be a part of the Transfer Steering Committee. The first meeting will be on October 27, 2016 in Lansing.

The Delta College President's Speaker Series is pleased to present Rosa Clemente, hip

The Delta College President's Speaker Series is funded by the President's Office and the Peter and Barbra Boyse Endowment Fund through the Delta Foundation. The event is free and open to the community, no tickets required.

- Dr. Goodnow said that the following information is included in folders this evening:
 - Descriptions of our 6 AQIP Categories. As a reminder, AQIP stands for the Academic Quality Improvement Program. AQIP is one of the accreditation pathways that is part of the Higher Learning Commission, the organization that oversees accreditation in 19 states (including Michigan).

At the ACCT Annual Summit attendees heard from Barbara Gellman – Danley, President of the Higher Learning Commission. She explained that the legislation that is being proposed by Senator Elizabeth Warren, Senator Richard Durbin, and others could potentially impact many institutions because it would rely on limited data sources. The proposed legislation

would also mean that there would be increased reporting requirements of accreditation activities to federal agencies.

President Gellman-Danley encouraged Trustees to stay involved with and aware of the proposed legislation and the impact it could have on community colleges.

She said that she values the leadership and the distance the College has travelled in that time. K. Houston-Philpot said that tonight's presentations on student success and the Saginaw Center were evidence of the excellence of Dr. Goodnow, the senior leadership, and the faculty and staff at the College.
