With 2 months left, the College has received most of the tuition and fees for the fiscal year. D. Lutz said that the variance on the revenue side that is a result of decreased enrollments is offset by a reduction in expenses because of the reserve that the College set aside last year for this purpose. D. Lutz said that she projects that the College will be over-budget in the area of instructional salaries, but that underspending due to vacancies throughout the year will off-set the overage.

- Dr. Goodnow reminded the Trustees that there is an invitation only reception Thursday evening from 5:30 p.m. to 7:30 p.m. at the Planetarium and Learning Center. The College is celebrating the 20th anniversary of the facility and have a number of our supporters who will be in attendance. Also, there will be a free, community wide open house at the Planetarium on Saturday, May 13, from 11 a.m. to 4 p.m.
- When Congress passed the federal budget extension last month, it included language restoring the Year Round Pell program for the 2017-2018 academic year. This will be great news for our students who may want to take additional classes and credits next spring and summer.
- Also included in the funding bill was \$445 million for the Corporation for Public Broadcasting and \$50 million for PBS' new interconnection system. Both of these items – Pell grants and CPB funding – were items that Chair Emrich, Vice Chair Middleton and Dr. Goodnow discussed with our legislators when they visited their offices back in February.
- A new advertising campaign will begin at the end of May. With input from Enrollment Services and Academics, the creative design follows the "Think Big" theme, featuring testimonials by students, graduates and faculty. The campaign will focus on key occupational programs. The campaign will feature billboards, social media, community magazines and newspapers, direct mail, and radio ads.

TRUSTEE COMMENTS	M. Benecke said she is looking forward to the Planetarium celebration. She thanked D. Lutz, her staff, and the Budget Cabinet for their work.
	R. E. Selby said that the next Dateline Delta caps the 20 th season and will feature Commencement, the Student Awards, our surgical technology program, information on summer camps, and our wind turbine program.
	M. Rowley said that he watched the QTV documentary on our local history and thought it was very well done.

M. Rowley said that he has been reflecting on last month's Dinner Meeting Presentation on enrollment management. Of particular concern are the low retention and graduat	
rates and the new competition we are facing. In addition, M. Rowley said that he is	1011
concerned with having a structurally unbalanced budget. He suggested considering a	way
to enhance the dollars that are awarded to our students by local foundations. In addi	tion,
he asked the Administration to consider an idea that was shared in Trustee Quarterly	
regarding "giving away credit hours." A student would pay for a certain number of ho	urs
in Fall and Winter and would receive "free credit" to use in Spring.	

K. Lawrence-Webster mentioned that she recently volunteered at Saginaw High and one of the reasons that students were choosing other colleges (she mentioned Jackson College) is because they have dorms.

D. Middleton said that she is encouraged by the restoration of summer PELL. She also commented on the employee hires/separations report for the month of April. She noted the years of longevity of those separating and retiring and said that in addition to providing and excellent experience for our students, we are providing an excellent experience for our employees.

D. Middleton said that she really enjoyed Commencement and the Student Graduate Awards.

R. E. Selby asked about progress on open educational resources. B. Webb said that there is a committee exploring options with publishers and a pilot should be ready in 2017-18.

M. Benecke said that we need disruptive innovation. She asked if we have data on what information students use to make their decisions.

CHAIR COMMENTS Dr. Emrich said that the College is focusing on retention and he participated in several conversations regarding retention strategies at the AQIP Strategy Forum in November 2016.

Dr. Emrich thanked his colleagues on the Board for thinking outside of the box. He said that this institution is facing challenges and the ideas of the Board and the entire institution will be needed to move through those challenges.
