CALL TO ORDER Board Chair Emrich called the meeting to order at 7:18 p.m.

APPROVAL OF AGENDA Board Chair Emrich said that the agenda for this meeting needs to be amended to correct

three clerical errors. The first two can be found in the consent agenda. The dates of the Board Dinner Meeting minutes and Board Regular Meeting minutes being approved need

to be changed to May 9, 2017.

The second area for correction is in the Support, Administrative/Professional, and Corporate Services compensation recommendation. The year should be 2017-2018.

R. Emrich called for approval of the amended agenda. D. Middleton made a motion to approve the agenda. M. Benecke seconded the motion. Motion passed unanimously.

PUBLIC COMMENT Board Chair Emrich called for public comment.

TREASURER'S REPORT D. Lutz said that the Board has received the College financial statements for the month

ended May 31, 2017. The College is in a strong cash position. As reported last month, the College's enrollments are down and tuition and fees are down. In addition, instructional salaries will be over budget. This overage will be offset by vacancies that the College has had in various areas throughout the year. The College will end the year "in the black" and

in a favorable financial position.

2017-2018 BUDGET AND TAX LEVY RESOLUTION (BA5187)

It is the recommendation of the administration that the Board of Trustees approve the 2017-2018 Budget and Tax Levy Resolution.

RESOLUTION OF JUNE 13, 2017

WHEREAS, the Board of Trustees has carefully examined the financial circumstances of the College District for the 2017-2018 fiscal year, including the following:

- (a) Estimated General Fund expenditures \$67,735,780
- (b) Estimated General Fund revenues from state appropriation \$16,317,278
- (c) Estimated General Fund from other revenue sources exclusive of local and State taxation \$29,285,455
- (d) Estimated revenues from local taxation Operational \$22,157,871

A total levy of 2.0427 mills, consisting of 1.5563 charter mills, and .4864 extra voted mills on the taxable value of all taxable property within the district necessary for the sound management and operation of the College District for such fiscal year; and

WHEREAS, the Board of Trustees has complete authority to direct a 2017 tax levy of 2.0427 mills for operating purposes for fiscal year 2017-2018 from within its authorized millage rate in order to raise approximately \$22,157,871 by taxation;

NOW, THEREFORE, BE IT RESOLVED THAT:

For the year 2017, the sum of \$22,157,871 be raised by taxation which shall require a total millage rate of 2.0427 mills to be levied against the taxable value of all taxable property located within the College District for community college purposes, that appropriate notification of such tax levy be sent to all taxing authorities within the College District with instructions that the taxes so collected should be turned over to the College Treasurer as required by law and

FURTHERMORE, THAT:

The 2017-2018 operating budget be adopted for the entire College in the amount of \$110,891,897 which includes the General Fund budget of \$67,735,780 as contained in the attached budget document.

BE IT FURTHER RESOLVED that the administration be authorized to effect modifications and additions to the budgets where such modifications and/or additions are in keeping

ADMINISTRATIVE PROFESSIONAL, SUPPORT STAFF, AND CORPORATE SERVICES COMPENSATION RECOMMENDATION FY 2017-18 (BA5188) It is the recommendation of the administration that the Board of Trustees approve for fiscal year 2017-2018, an increase of 1.9% in the Administrative/Professional, Support Staff and Corporate Services non-grant funded and non-contract wage and salary schedule to be granted to individual staff in accordance with the performance management system calculation of annual increases and with the contribution to medical insurance premium remaining at 20%.

R. E. Selby made a motion to approve the resolution with support from M. Morrissey.

Motion passed unanimously.

RECOMMENDATION TO APPROVE PRESIDENT'S COMPENSATION (BA5189) R. Emrich read the following summary as written by M. Nash, Chair of the President's Compensation and Evaluation Committee:

"The Delta College Board of Trustee's annual review of Dr. Goodnow was favorable. Dr. Goodnow was successful in leading Delta College during the 2016-2017 school year. The Board was particularly pleased with Dr. Goodnow's efforts in fostering student success while enhancing the College's reputation as a top-tier community college through efforts at the local, state and national levels. Dr. Goodnow made measurable progress on all of her goals. Specifically, the progress towards the new Saginaw Center was strong. The Board identified several areas of focus for Dr. Goodnow heading into the 2017-2018 school year; continued progress with the Saginaw Center; a collaborative, Board-directed initiative to address the sustainability of the college's go-forward operating model; and the ongoing pursuit of professional development and growth. Following the favorable review, the Board is bringing forward tonight a recommendation for a pay increase for Dr. Goodnow."

It is the recommendation of the President's Compensation and Evaluation Committee that the Board of Trustees approve an increase of 2.84% to the President's Annual Base Salary and an increase of 5% (based on the 2017-18 Base Salary) in the annual employer non-elective contribution to a tax-sheltered annuity that the College makes on behalf of the President.

R. Emrich made a motion to approve the recommendation with support from M. Benecke.

STUDENT SUCCESS

Margaret Mosqueda, Vice President of Student and Educational Services introduced this evening's presenters: Martin Finney, Career Advisor; Dan Segura, Associate Director of Counseling, Advising, and Careers Services; and Rachel Kozuch, Office Professional – Science and Mathematics Division.

M. Finney provided an overview of Career Services. Career Services provides assessments, career exploration, and program exploration opportunities. The data utilized through the Career Coach program allows students to access career data for our area (within a 50 mile radius).

R. Kozuch shared her success story with the Board. She spoke about the impact that the student employment opportunities she had in the Mathematics Division, Instructional Support Services, and the President's Office had on her success as a student and, ultimately, as a full-time employee of Delta College. She noted that, "Delta College has made such a difference in my life."

The spring semester began on Monday, May 8. To-date 3,877 students are enrolled. (3,632 part-time, 245 full-time).

Registration for the Fall 2017 Semester began on Tuesday, April 11. To-date, 5,513 students have registered (3,520 part-time, 1,993 full-time).
