CALL TO ORDER Board Chair Thomas called the meeting to order at 7:01 p.m.

APPROVAL OF THE AGENDA

Board Chair Thomas asked for a motion to approve the agenda.

TREASURER'S REPORT

S. DuFresne said that the Board packet includes financials as of June 30, 2023. The financials presented are a very early close. This means accruals and year-end entries are still being made and will likely be finalized in September. S. DuFresne said that she has no material variances to report and said the College will finish the year in the black.

ADMINISTRATIVE REPORTS - BEDI UPDATE Dr. Pam Ross McClain, Chief Officer of Culture, Belonging, and Community Building gave on update on BEDI work at the College. BEDI stands for "belonging, equity, diversity, and inclusion." She discussed the work that's been done in the last year, including a new BEDI Services Division to be housed in the lower west courtyard. Dr. Ross McClain said that the new division includes two new positions and several existing positions that have

been realigned to create a department that will focus on creating a safe learning space for all. She said she sees that team as student resource navigators, but to be successful, and to truly make BEDI part of the culture it has to be "all of our work."

ADMINISTRATIVE REPORTS – STUDENT SUCCESS – PLANETARIUM UPDATE

Mike Murray, Astronomer and Planetarium Manager gave an overview about the planetarium. He highlighted the fact that in 2022-23 the planetarium attained the highest revenue and attendance since its opening year. He attributed this achievement to teamwork, as well as the availability of stellar programming.

PRESIDENT'S REPORT

Enrollment Report

The Spring/Summer 2023 semester ends on August 17. Delta projected 22,954 contact hours for the semester and came in at 107% of budgeted projection, with 24,658 contact hours.

Registration is underway for the Fall 2023 semester. As of today, 6,810 students have registered. Delta projected 71,884 contact hours for the fall semester and we are currently at 98% (70,403 contact hours) of projection. Fall classes begin on August 26.

Information Sharing

- Congratulations to Thomas Boudrot, Associate Professor in Political Science, who
 was awarded a one-semester sabbatical for 2024-2025. His project is to complete a
 DEI Certificate from Cornell University and develop professional development
 modules for Delta faculty and staff.
- A special board meeting was held on June 19 for professional development. Dr. Jill Wakefield, from the Association of Community College Trustees facilitated. A presentation on parliamentary procedures by Dr. Roslyn McQueen was also part of the session.
- In other professional development news, 25 Delta faculty and staff participated in Adult Mental Health First Aid Certification Training. The training was conducted by Dr. Matt Samocki, Executive Director of Bay Region Mental Health Partnership, and Rob Vallentine, National Trainer for National Council for Mental Wellbeing.
- The Michigan Community College Association's summer conference was held July 26-28. Thanks to all the trustees who were able to attend.
- The Great Lakes Bay Regional Chamber Summit was held today. Trustee Middleton, thank you for your leadership in the community to make this event possible.

- M. Rowley thanked Dr. Gavin for providing him with a copy of the cybersecurity presentation from the June meeting as he was unable to attend. He said that he would like to know more about encryption and how advanced we are at the College.
- M. Rowley said that he had the opportunity to participate in the "Under the Radar" program that was hosted by Broadcasting. He congratulated Pam Clark and her staff for a "very cool event."
- M. Rowley said that as the MCCA representative for the College he is monitoring the situation with the new oversight agency that Governor Whitmer is proposing. He said that the Michigan Board of Education is taking the position that this agency may violate the Michigan Constitution.
- S. Gannon said that the MCCA Summer Institute was wonderful. She congratulated P. Ross McClain (the BEDI Jedi) on the progress that is being made. S. Gannon also thanked M. Murray for an excellent presentation.
