CALL TO ORDER

Board Chair, R. Stafford, called the meeting to order at 7:19 p.m.

APPROVAL OF AGENDA

Board Chair, R. Stafford, called for approval of the agenda.

The agenda was approved as presented.

PUBLIC COMMENTS

Board Chair, R. Stafford, called for public comment.

Cheryl Hadsall, Saginaw County Board of Commissioners, representing the 7th District, said that she hopes that the Board decides that Delta College should remain in Buena Vista. She said that she represents people in areas such as Birch Run, Albee, and Bridgeport. People in this district are concerned that if the Center is moved to a different location it will be too far away and not as accessible. She also added that she was at the meeting as a member of the Birch Run High School Scholarship Foundation Board.

Jessie Merrill, a resident of Buena Vista Township and a Delta College student, said that he would like to see the Delta College Saginaw Center remain in Buena Vista. He noted that for many students who come from outside the district it is an accessible site.

Charisma Bassett, Buena Vista resident and Delta College student said that Ricker is like another home to students in Buena Vista and Bridgeport. She encouraged the College to remain in Buena Vista.

Gerald Kariem, resident of Saginaw County and UAW representative, encouraged the Board to carefully consider the Buena Vista site.

Dexter Mitchell, Buena Vista Township Supervisor, said that the township has had an excellent relationship for 20+ years. He said he would like to see that relationship continue. He added that any decision will be a win for Saginaw.

Dawn Goodrow-Hillier, resident and business owner, from the City of Saginaw, encouraged the College to move downtown and help to revitalize the downtown core.

Tom Trombley, Downtown Saginaw Associate Representative, said that the Downtown area would like to be a strong partner with Delta College.

Jim Graham, Buena Vista DDA, thanked Delta College and the Board for including Buena Vista as part of this process. He said that Buena Vista has a lot to offer and he would like to "welcome Delta College back" to Buena Vista.

Desmond Bibbs, Buena Vista DDA and PNC Bank Representative, said he hopes Delta College will remain in Buena Vista and said that PNC Bank is invested in education and would have resources to offer in the future.

Amos O'Neal, City of Saginaw, thanked the Board and the College for their commitment to Saginaw. He said that the data shows that Delta College should move into the Downtown Saginaw Area.

TREASURER'S REPORT

D. Lutz said that at the end of the month of December, the College remains in solid cash position. Enrollment for the Winter 2014 semester is down about 1,900 credit hours which equates to approximately \$250,000 in lost revenue for the College. D. Lutz said at this time she has no additional variances to report.

CONSENT AGENDA

R. Emrich asked that, item D, Senate Policy 3.055, Professional Development Allowance, be removed from the consent agenda.

M. Rowley made a motion to approve the amended consent agenda with support from R. E. Selby. The consent agenda passed unanimously resulting in:

SENATE POLICY 3.055, PROFESSIONAL DEVELOPMENT ALLOWANCE (BA5041)

It is the recommendation of the Administration that the Board of Trustees approve revisions to Senate Policy 3.055, Professional Development Allowance.

- M. Rowley made a motion to approve the recommendation with support from R. E. Selby.
- R. Emrich said that he thinks that there should be a revision to the policy because there is a difference between "deductible" and "reimbursable."
- D. Lutz gave an overview on the reason for the policy revision and said that the changes were made in accordance with IRS guidelines.
- K. Lawrence-Webster made a motion to approve the recommendation to include a reference to IRS Publication 15B with support from R. Emrich.

Following discussion, R. Emrich moved the previous question. The motion to amend the recommendation failed unanimously.

The original motion passed unanimously.

SOUTH CAMPUS SITE IMPROVEMENTS – WARRANTY REPAIRS (BA5042)

It is the recommendation of the Administration that the Board of Trustees approve the payment of \$150,000 to Champagne and Marx Excavating, Inc. of Saginaw for the installation of drainage tile and "betterment" received as part of the warranty repairs associated with the South Campus Site Improvements project.

- K. Lawrence-Webster made a motion to approve the recommendation with support from M. Rowley.
- R. Emrich asked E. Crane if the Board could go into closed session to discuss. E. Crane said that she was going to provide a conservative opinion and say no due to the fact that there is currently no pending litigation on this matter and there was a waiver of attorney client privilege when the information was shared with individuals in addition to the attorney and client. This occurred when Larry Ramseyer's memo explaining the background information was placed in the Board packet.
- R. Emrich said in the future, this information should not be published. R. E. Selby said that he is frustrated that the privilege was waived (and not by the Board).

Motion passed unanimously.
