MCCA UPDATE – GUEST: MIKE HANSEN PRESIDENT OF MCCA

Board Chair Emrich introduced Mike Hansen, President of the Michigan Community College Association.

M. Hansen thanked Trustee Emrich and Trustee Selby for their long-time support of the MCCA.

M. Hansen reviewed the current budget situation for community colleges in Michigan. He said that the Governor has not recommended an increase for community colleges for the first time. He said that he believes that this is in relation to payments that will become available to community colleges as reimbursement for lost personal property tax revenue. M. Hansen said that he is advocating the community colleges deserve a 2% increase to the base funding from the State of Michigan.

Other areas in which MCCA is focusing this year are on capital outlay, the New Jobs Training Program, transfer, and advocating at the federal level.

He thanked Delta College for the continued advocacy at the federal level.

M. Hansen also said that MCCA has developed a draft of guidelines regarding the "gentleperson's agreement" between the 28 community college presidents. At this time, there is not full agreement on the wording of the draft. R. E. Selby said that this issue merits discussion with the full MCCA Board of Directors.

R. E. Selby said that the MCCA is in a much better place as a result of Mike Hansen's leadership. Board Chair Emrich thanked Mike for taking the time to visit and talk with the Delta College Board.

- On February 17, at the Saginaw Future 25th Annual Awards Luncheon, Delta College received the Economic Excellence Award for outstanding contribution to the economy of Saginaw County in 2016. We also received certificates for special congressional recognition from State Senator Mike Green, Representative Dan Kildee, and Representative John Moolenaar.
- On Saturday, February 25, Delta College hosted the 2017 Region 4 Science
 Olympiad with nine area middle schools and 11 high school teams competing.
 Thank you to Jon Gittins, Assistant Professor in Chemistry; Mike Pressler, Assistant
 Professor in Biology; and Aron Drake, Biology Instructor; for coordinating this
 event. Dr. Goodnow said that she appreciates all of the faculty and staff that
 worked to make this a successful event, especially those in the Science Division,
 Facilities Department, and Food Services.
- Last year, Phi Theta Kappa launched REACH Rewards which is a program designed to recognize and reward Phi Theta Kappa chapters that excel in the area of membership development. Dr. Goodnow announced that the Xi Delta Chapter has been named a 2017 REACH Chapter and will be receiving special recognition in the form of 5 Phi Theta Kappa graduation stoles. These stoles will be distributed to chapter officers or members to be worn during graduation and to keep as a celebration of the milestone of college completion, while also encouraging other students to do the same. Thank you to Crystal Starkey for her leadership as the advisor for this honors group.
- Dr. Goodnow encouraged Trustees to take a look at this month's Fantastic Faculty which has been uploaded to BoardBook.
