APPROVAL OF AGENDA Board Vice Chair Middleton called for approval of the agenda. M. Nash made the motion.

TREASURER'S REPORT S. DuFresne said that the Board has received the College's financial statements for the

month ended August 31, 2018. She said it is early in the academic year and at this time she has no significant variances to report. S. DuFresne said that the College did not make the enrollment projects for the Summer or Fall 2018 semesters. At this time tuition

revenue is approximately \$450,000 less than budget.

BOARD ACTION Architect Selection for Delta College Midland Center

(BA5252)

It is the recommendation of the administration that the Board of Trustees approve the selection of Tower-Pinkster to provide architectural and engineering services for the Delta College Midland Center project.

M. Benecke made a motion to approve the recommendation. K. Peatross seconded the motion.

BOARD ACTION Campus Entrance Digital Signage (BA5253)

It is the recommendation of the administration that the Board of Trustees approve to award a contract for the campus entrance digital signage project to Sign Image Visual Communications Group of Saginaw, Michigan for \$141,505.92 and that the total project budget of \$254,000 be approved authorizing the Facilities Department and administration to award contracts to complete the project.

M. Morrissey made a motion to approve the recommendation. M. Benecke seconded the motion.

Motion passed with 7 in favor. M. Nash voted in opposition.

BOARD ACTION Delta College - Strategic Value (BA5254)

It is the recommendation of the administration that the Delta College Board of Trustees certify to the State Budget Director that Delta College has met ALL 5 of the best practices listed in each of the categories required through Public Act Number 265 of 2018, Section 230 (3), thus exceeding the legislative requirements.

M. Benecke made a motion to approve the recommendation. K. Peatross seconded the motion.

Motion passed unanimously.

BOARD ACTION Approval of President's Goals (BA5255)

D. Middleton said that Dr. Goodnow submitted a draft of her goals to the Board in August and asked for the Board to provide feedback. She asked if the Board was ready to approve the goals.

M. Nash made a motion to approve the President's Goals for 18-19 as written. M. Rowley seconded the motion.

Classes for the Fall 2018 Semester began on August 25. As of today, 8,100 students are enrolled (5,226 part-time, 2,874 full-time).

 - A 2018 PBS booklet. As the cover indicates, PBS has been deemed one of America's most trusted institutions, for the 15th straight year. If you take a look at the charts on pages 2 and 3, you can see how highly PBS ranks in recent surveys. And, on pages 10 and 11, there's great statistics on our Children's programming. There's a lot of great information in this publication, so I hope you'll take the chance to read through it at home.

In terms of funding, the Senate passed the Fiscal Year (FY) 2019 combined Defense and Labor, Health and Human Services and Education (Labor-HHS-Education) appropriations bill by a vote of 85-7 in late August. The bill provides level funding for public broadcasting. That would impact the \$737,023 in funding Delta College's WDCQ-TV would receive from the Corporation for Public Broadcasting.

There were no amendments made to the bill targeting public media funding for cuts, which is good news. Congress has continued to show strong bipartisan support for local stations and our services. The bill still needs to pass in the House and then be dealt with in Conference prior to the end of the fiscal year on September 30th.

Sarah DuFresne and Scott Lewless provided a benefits update to the Board. The presentation included:

- An overview of the Benefits Committee including the representation of the committee.
- A summary of the 2017 Health Benefits costs to the institution.
- An overview of plan design changes that will be implemented, effective January 1, 2019 – as well as estimated budgetary savings.
- An overview of plan design changes that will be implemented in 2020 and 2021.

There was discussion regarding the benefits including questions about who would provide the HSA (Arcadia Benefits) and the way the changes would be communicated.

Sarah said that there will be several communications including open forums that will be focused on explaining the changes.
