S. DuFresne said the Board has received the financials for the month ended March 31, 2019. She said that she has reviewed the financials and has one variance to report. The endowment fund is showing a deficit of \$817,000. This is a timing issue and will not be the case next month. S. DuFresne said that at this time she has no additional variances to report.

BOARD ACTION

Approval of Computer Purchase from Dell Inc. (BA5283) It is the recommendation of the Administration that the Board of Trustees approve the purchase of 209 computers for academic classroom and computer labs and faculty and staff, seven servers and storage hardware and software as part of the data center life cycle replacement at a cost of \$663,696 from Dell Corporation.

R. Emrich made a motion to approve the recommendation. M. Thomas seconded the motion.

Motion passed unanimously.

BOARD ACTION

Approval of Saginaw Center Sculpture

It is the recommendation of the Administration that the Board of Trustees approve the acceptance of the Saginaw Center Sculpture as presented, including the placement of the

- S. Gannon spoke about how wonderful the artist, Ken Newman, is to work with. J. Goodnow said that she is very excited to have one of this artist's sculptures at the Delta Downtown Saginaw Center.

Motion passed unanimously.

BOARD ACTION

Approval of East Parking Lot and South Roadway Repairs (BA5285)

- N. Bovid presented the recommendation of the Administration that the Board of Trustees approve the project budget of \$735,500 and authorize the Facilities Department and administration to secure bids, and award contracts to complete the East Parking Lot and South Roadway Repairs project as detailed in the current project plans designed by SmithGroup, LLC.
- R. Emrich made a motion to approve the recommendation. M. Benecke made a motion to support.
- R. Emrich asked why the bids were not included with this proposal and why the proposal included authorization to secure bids. He said that the process he is accustomed to includes information regarding the vendor recommendation.
- N. Bovid said that the College secured bids and presented the bids that were received. He said that the Administration would like to contract with Mid-State Earthworks, Inc. of Freeland. J. Goodnow apologized for the change in the way in which this information was brought forward and thanked the Board for their consideration of this recommendation.

Following the discussion, R. Emrich withdrew his original motion.

- M. Rowley made a motion that the Board of Trustees approve the project budget of \$735,500 and authorize the Facilities Department and Administration to award the contract to complete the East Parking Lot and South Roadway Repairs project as detailed in the current project plans designed by SmithGroup, LLC. to Mid-State Earthworks, Inc.
- R. Emrich seconded the motion.

Motion passed unanimously.

BOARD ACTION

Approval of Replacement Phone System Purchase (BA5286) It is the recommendation of the Administration that the Board of Trustees approve the purchase of a replacement phone system to I.T.I., Saginaw, Michigan for a VoIP system at a total project cost of \$367,650.

M. Benecke made a motion to approve the recommendation. R. Emrich seconded the motion.

Approval of Placemaking Initiative Project (BA5287) It is the recommendation of the Administration that the Board of Trustees approve the Placemaking initiative project in the amount of \$568,360.

- S. Gannon made a motion to approve the recommendation. M. Thomas seconded the motion.
- M. Benecke asked how the College was paying for this.
- J. Goodnow said that the funding for placemaking is coming from the money the College transferred to the Plant Fund at the end of 2017-2018 when the College received a much larger personal property payment than expected. At the end of 2017-2018, the college also established an additional fund set aside for sustainability this was savings from our 2017-2018 budget and some of the personal property tax money. Those dollars were placed in the designated fund to be used for needs like our voluntary employee severance plan. The money transferred to the Plant Fund so far has been used for approved one-time large projects. The projects include the phone system replacement (on tonight's agenda for approval), the security cameras and door access controls, the digital entrance signs, and placemaking.
- M. Rowley commented that the College is seeing declining enrollment, and we need to slow down spending and keep reserves in our rainy day fund. Placemaking is a lot of money, but we want our students when they come to Delta, to validate their decision to be here. "With less students, we need to spend our money wisely. If we need to spend some of our reserves, I caution how we spend money in the future."

Motion passed unanimously.

Information Sharing

 Dr. Goodnow thanked the Trustees for their participation in our 2019-2023 Strategic Planning Visioning Meeting on Thursday, March 14. For those Trustees who were unable to attend, she assured them that their feedback was incorporated into the discussion throughout the day. There are DVDs of the meeting in Board folders this evening.

Our facilitator, John Politi, did an excellent job of summarizing the information from the day and providing it as a guide for the work our Executive Council and Strategic Planning and Institutional Effectiveness Steering Committee are currently engaging in. We are in the process of working through setting our measures, which we call

"Indicators of Success." Andrea Ursuy and Dr. Goodnow will be sending Trustees an update on the plan progress in the next couple of weeks. In June, the Administration will ask the Board to approve the plan.

- Last week, the articulation agreement between Delta College and Franklin University
 was renewed. Delta students with associate's degrees transferring to Franklin
 University will have junior standing.
- In addition, the College renewed Articulation Agreements with Eastern Michigan University. The following agreements originated in 2005. They have an annual administrative review for changes and renew every four years.

Associate of Business Studies (ABS) in General Management, Marketing Management or Entrepreneurship and Small Business Management degree programs articulate to Bachelor of Business Administration (BBA) any Business Major.

O Under this agreement Eastern (EMU) will waive their rule that 60-hours must be completed at the university and allow Delta's entire degree - up to 82 credits to transfer with students completing 42 credits at EMU. The EMU program allows up to 31 elective credits making it flexible for various ABS programs. Most PUBLIC universities will not allow more than 62 credits to transfer because of the 60-credit rule. In addition, many other public universities have courses in their Major at a 300/400 level and will not allow community college 200 level courses to transfer as an equivalent.

The Associate Business Studies, Legal Support Professional degree to Bachelor of Science in Paralegal.

- O Under this agreement, Eastern will waive their rule that 60-hours must be completed at the university and allow Delta's entire degree up to 85 credits to transfer with students completing 39 credits at EMU. The Eastern Paralegal program is the only one in the country that has an attorney-supervised legal clinic for paralegal students. Most public universities will not allow more than 62 credits to transfer because of the 60-credit rule. Many other public universities have courses in their Major at a 300/400 level and will not allow community college 200 level courses to transfer as an equivalent.
- The Employee Awards Banquet took place last Friday at the DoubleTree Hotel in Bay City. It was a wonderful event. Dr. Goodnow said she is grateful to all the faculty, staff, Trustees, and special guests who attended.
- Last Friday, Delta College had the opportunity to host the Mid-Michigan High School All Star Basketball Tournament for area high school seniors. This event also included games for middle school youth. Carlos McMath, Men's Basketball Coach, played an intricate role in making this event a success.
- Friday, April 12, Delta College will be hosting the "Hoops for the Homeless" game beginning at 6:00 p.m. The price of admission is food items for the Delta College Food Pantry. "Hoops for the Homeless" is an annual fundraiser benefiting Rescue Ministries of Mid-Michigan to raise operating funds for the Good Samaritan Rescue Mission of Bay City and the City Rescue Mission of Saginaw.
