PRESIDENT'S REPORT

Enrollment Report

The Spring/Summer 2022 semester ends on August 18. As of today, 3,121 students are enrolled. The College projected 20,017 contact hours for the spring semester and we are at 112.5% of budgeted projection (22,512 contact hours).

Registration is underway for the Fall semester and 6,090 students have registered, as of today. The College has a goal of 73,850 contact hours and are currently at 86.30% (63,734 contact hours). Fall classes begin on August 27.

Personnel Report

Dr. Gavin welcomed Dr. Pamela Ross McClain as the new Chief Officer of Culture, Belonging and Community Building. Pam began in her new role at Delta College on August 1. She has been working in education for approximately 26 years. Pam came to us from the University of Michigan, Flint where she was an Associate Professor in the School of Education and Human Services for the past four years. She has also worked for the Saginaw Public School District and Saginaw Valley State University.

Pam's educational background includes a:

- Bachelor of Arts in English & Afro-American and African Studies from the University of Michigan, Ann Arbor (MI),
- Master of Professional Studies in Afro-American Studies with emphasis in Education from Cornell University, Ithaca (NY),
- Secondary Teaching Certificate major in English and minor in History from Saginaw Valley State University (MI),
- Ph.D. in Department of Teacher Education from Michigan State University, East Lansing (MI) – Program: Curriculum, Teaching, and Educational Policy and Cognate: Teacher and Staff Development

Dr. Gavin also announced the hiring of Chad Inabinet, our new Vice President of Student Empowerment and Success. Chad will be joining us after serving as Dean of Student Services for 13 years at West Shore Community College. He will officially begin on August 29.

- These articulated credits are intended solely for use towards an Associate of Applied Science (AAS) in one of Delta's allied health programs or the AAS in Fire Science. Articulated credits are generally not transferable to another institution.
