STUDENT SUCCESS: THE DOWNTOWN SAGINAW CENTER The Student Success Report entitled "You Belong Here – the Downtown Saginaw Center" was given by Kristy Nelson, director of downtown centers, and Monica Hernandez-Alaniz, assistant director.

They discussed efforts to engage with students and the local community. They also highlighted the one-spot services they offer. Students Connie Rivera, Sade' Jackson and Eboni Williams talked about what they love about the center and how the staff is helping them in their higher ed journeys.

The center has 528 students enrolled for fall semester, 10 percent are dual enrolled students. Program offerings include: associate of arts, Michigan transfer agreement, fire science, certified medical assistant and phlebotomy.

PRESIDENT'S REPORT

Dr. Gavin summarized many of the improvements that have happened at the Saginaw Center in the past year, including more staff for security, a full-time advisor, the Saginaw Academy of Excellence, and a bus route to main campus.

Enrollment Report

Winter 2023 registration is underway. As of today, 4,972 students are registered. The College projected 67,211 contact hours for the winter semester and is currently at 70 percent of projection. Winter semester begins on January 7, 2023.

Information Sharing

- Thank you to the Trustees who were able to attend the Mission, Vision and Values Summit on October 14. The work continues as the Writing Team takes the input and drafts updated versions of these guiding principles. The College Community will have an opportunity to comment on the draft and the Board will be asked to approve.
- Dr. Gavin said he attended the ACCT Leadership Congress in New York City on October 26-29, along with Trustees Nash and Thomas. He attended sessions on mental health, childcare and others about putting a social support net around students through community partnerships. This is active work Delta is engaged in now. The non-profits in our communities are very interested in partnering in this endeavor. A group from Delta will be traveling to San Antonio Community College to learn more about the support they provide through their student advocacy center.
- Diane Lobsinger-Braden, professor, and Becki Bushong, learning resource manager, updated the group on the planning for Girls' Day Out 2023. The event for 6-8 grade girls will be held virtually and in-person on Friday, March 24.

As he toured, however, only one class was in session. He'd like to see increased utilization of the building. Chair Nash asked that the Nominating Committee meet to develop a draft recommendation for the Board Chair, Vice Chair, Secretary, and Treasurer. The report will be shared in December and the officers will be voted on as part of the Board's organizational meeting in January 2023.
