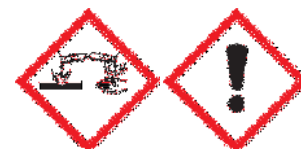

#### **6. ACCIDENTAL RELEASE MEASURES**

#### **7. HANDLING AND STORAGE**
